MINNEHAHA COMMUNITY WATER, CORP. FORTY FIFTH ANNUAL MEMBERSHIP MEETING Wednesday, May 19th, 2022

Minnehaha Community Water, Corp. held its Forty-Fifth Annual Meeting using a "Come and Go" Format on the Thursday, May 19, 2022. Members were invited to visit the office between the hours of 1:00 p.m. to 3:00 p.m. There was an attendance of 5 members.

All members were sent a ballot which registered them to vote; confirmed they were given the annual audit report, approved the minutes from last year, and cast 2 votes for to elect David Stearns, David Howard or Mike Cypher.

Quorum of 165 members were present in person or by proxy. There were 153 votes to approve the minutes and 0 Nays, 153 votes to approve the audit report and 0 Nay, and 141 votes for David Stearns, 111 for David Howard and 69 for Mike Cypher. David Stearns and David Howard were re-elected to the board.

All Members returning their ballots were given an opportunity to receive a \$50 water bill credit. As part of our ongoing efforts to improve services to our customers, the website Eye On Water helps you monitor your water usage by offering you direct and secure access to your water usage data. Eye on Water is a secure online website and smartphone app to review and analyze your usage patterns. With these tools, you are now able to view your hourly usage activity and gain greater understanding and control of the amount of water you use. Please take advantage of the leak alert feature with Eye On Water to receive the fastest notification of leaks. You can be alerted via email or text message when you have a leak.
