Executive Director's Comments



MCWC delivered 1.21 billion gallons of water in 2022. This is the third year in a row that the system has exceeded the billion gallon sales level. The largest pumping day in 2022 was 6.5 million gallons on July 31st. On that day, MCWC used our full allocation of Lewis & Clark water and ran both treatment plants, which reinforces the need for additional treatment capacity.

MCWC is now working with Big Sioux Community Water to secure additional raw water supply and to build treatment and distribution capacity. The shared treatment plant project was awarded \$34 Million in ARPA grants. The remaining \$100 Million in project costs will be funded with low interest loans through SD DANR.

Construction for new customers remains strong and we expect the demand to increase yearly as more businesses come to Minnehaha County. Our two water tower projects will be finished and ready for service by early summer. Large water main line is planned between Hartford and Humboldt. While pipe prices are starting to come down from their highest levels, they are still twice as expensive as their pre-pandemic costs. Delivery on pipe and construction materials is improving slowly.

The 2022 MCWC consumer confidence report has been posted to our website. The report summarizes water quality information and test results. Please feel free to call our office with any questions.

At the annual meeting, we will be voting on three director positions. Lloyd Rave, Rod Van Der Vliet, and Brian Howe are completing their current terms and will be running for reelection. Any member that is interested in running for the board of directors should contact our office to receive a petition.

EyeOnWater

You now have online access to your hourly water usage information via Eye On Water!

As part of our ongoing efforts to improve services to our customers, the website Eye On Water helps you monitor your water usage by offering you direct and secure access to your water usage data. Eye on Water is a secure online website and smartphone app to review and analyze your usage patterns. With these tools, you are now able to view your hourly usage activity and gain greater understanding and control of the amount of water you use. You are also able to establish leak alerts that will notify you when you have a leak that occurs for more than 24 hours.



To view your account online you must visit https://eyeonwater.com/signup

- 1: Enter your account number
- 2. Enter your service zip code
- 3. Enter and confirm your email address
- 4. Create and confirm your password
- 5. Verify your email address in the confirmation email

MCWC staff periodically review unusual water use patterns, but it is <u>ultimately</u> the customer's responsibility to monitor their own account. Please take advantage of the leak alert feature with Eye On Water to receive the fastest notification of leaks. You can be alerted via email or text message when you have a leak.
