The corporation will install, at the water user's expense, a meter pit and service line to the corporation's nearest mainline distribution pipe. Such meter pit shall be installed in a location agreed upon between the water user and the corporation. The corporation shall provide at the corporation's expense, a water meter for each service. The corporation shall have the exclusive right to use the water shutoff valve and water meter, and to turn the service on and off.

The water user agrees to grant or convey or shall cause to be granted or conveyed to the corporation, its successors or assigns, a perpetual easement in, over, under and upon the above described land, with the right to erect, construct, install and lay, and thereafter use, operate and inspect, repair, maintain, replace and remove water pipelines and appurtenant facilities, together with the right of ingress and egress over adjacent land for the purpose mentioned above. The corporation shall have final jurisdiction in any question of location of said easements and service connection.

Duly authorized agents of the corporation shall have access, at all reasonable hours, to the premises of the water user for the purpose of installing or removing the corporation's property, inspecting piping, reading, or testing meters, or for any other purpose in connection with the corporation's service and facilities.

The water user agrees to pay for water service at such rates, time and place as shall be determined by the corporation and shall otherwise abide by all the Bylaws and rules and regulations adopted by the corporation. Monthly charges for water service will commence thirty (30) days after the water service line is installed and operational, or one year from the date the hookup is approved by the manager, whichever is sooner.

The corporation shall have the right to determine the allocation of water to users in the event of a water shortage. The corporation may shut off the water to a water user who allows a connection or extension to be made to his service line for the purpose of supplying water to another user. No resale of the water from this system shall be allowed. Violation of this provision shall constitute cause for disconnection of a water user's service.

The failure of a water user to pay charges duly imposed, shall result in the automatic imposition of the following penalties:

- A. Payment received after the twentieth (20th) of each month will be subject to a late charge.
- B. Nonpayment within thirty (30) days after the original due date will allow the corporation, upon due notice, to disconnect the water service.
- C. In the event it becomes necessary for the corporation to shut off the water from a water user's property, a fee will be charged for reconnection of the service.
- D. Non-payment of any amount owing to the corporation for a period of more than one (1) year shall, without further notice, result in a complete forfeiture of any rights held by the water user under this agreement.
